

ARRIVAL INFORMATION/SHOW OFFICE/ EQUINE HEALTH INFORMATION

Kentucky Horse Park is exit 120 off I -75 north of Lexington, KY. Go east on Iron Works Pike and enter horse park at main entrance from Iron Works Pike. Go pass Parking Booth, turn left onto Jenny Lane, turn right onto Nina Bonnie. Follow signs for **EVENT STABLING**. Stabling assignment will be listed by the name provided on the entry form (owner or farm/stable). Pre-entered horses with reserved stalls will have posted stalls. Horses must be unloaded in designated areas. Parking of horse vans, trailers should be in designated areas. Trailer combinations can be parked in the camper area. **BARN 5, 6, & 7 NEAREST THE INDOOR ARENA will be used for Morab Show**

Horses coming in for the Dressage show Friday October 26, will use backside of Barn 7 #’s 719 -736

ORIGINAL COGGINS REQUIRED TO PRESENT TO SHOW SECRETARY - ALL KENTUCKY AND OUT OF STATE HORSES WILL NEED COGGINS WITHIN A YEAR OF ENTRY AND A CERTIFICATE OF VETERINARY INSPECTION WITHIN 150 DAYS : OUT OF STATEHORSES NEED A CERTIFICATE OF VETERINARY INSPECTION WITHIN 30 DAYS OF ENTRY

It is recommended that all horses be vaccinated for Equine EHV-1 no sooner that 7 days and no later than 120 days prior to entry and that date of vaccination be noted on the Certificate of veterinary Inspection.
