

## Kentucky Horse Park Rules

- 1.) **BARN AISLES/ENDS** - No parking allowed. Unloading/Loading only in these areas.
- 2.) All parking must be within designated areas only. Trailers are to be dropped off at the South End of the Main Visitor Parking Lot.
- 3.) **CAMPERS/R.V.'S/HORSE TRAILER/W/LIVING SPACE** - Must go to campground for water/electric hook-up, unless event has made separate arrangements with KHP Special Events. **NO HOOK-UP ALLOWED TO THE BARN AT ANY TIME!**
- 4.) **SHOW GROUND PASSES** - Must be obtained from the Parking Booth upon entry. \$5.00 fee assessed for each pass per event. **ALL VEHICLES MUST SHOW A PARKING PASS.** Parking in unauthorized areas may result in citations or removal of vehicle at owner's expense.
- 5.) **SHOWING OUT OF TRAILER** – **Must** purchase a Trailer Day Pass or Seasonal Pass at the KHP Show Office on Nina Bonnie (White Building) before barns 5-6-7. Day Pass - \$20; Seasonal Pass \$75. Must show pass to show secretary.
- 6.) East Arena Rd is restricted to day parking for exhibitors that show out of their trailers and spectators.
- 7.) **HORSE'S AND HORSE DRAWN VEHICLES** - Have the right-of-way at all times.
- 8.) **DOGS** - Must be on leash not to exceed 6 feet or tied or suitably restrained in a tack stall/cage etc. at all times. Loose animals or animals left in vehicles in distress, etc, can and will be removed from the grounds at the owner's expense.
- 9.) **GOLF CARTS/MOPEDES ETC.** - A privilege - *not a right* - extended to show participants. Operators must be at least 16 years of age with valid driver's license. Not allowed in the Tourist/Visitor areas of the Park. All golf carts must obey all traffic laws and posted speed limits. Golf carts can be rented through Devers Show Services. **ATV's and skateboards are strictly prohibited in all areas of the Park.** Golf carts, bicycles and mopeds are permitted in designated show areas only. Golf carts and mopeds require a valid driver's license. **NO DRIVERS UNDER AGE 16. NEW Exhibitors wishing to bring their private golf carts onto Kentucky horse Park property must purchase a Golf Cart License. This license can be obtained at Devers Show Services for \$25 per show or \$50 for the season.**
- 10.) No bulk saw dust or wood shavings are allowed to be delivered to Park grounds by commercial hauling companies or saw mills for sale or distributed to horse show exhibitors.
- 11.) **PACKAGES/DELIVERIES** - The Park is **NOT** responsible for any deliveries to an event or event participant. Receiving party must be present when delivery is expected. Park mail service personnel will try to assist if conditions allow, however, any delivery/package may be refused/returned to sender, etc at any time without notification.
- 12.) **PARK ADMISSION** - Reduced Park admission is available to event participants and must be obtained at The Visitor Information Center. Proof of event participation may be required at time/point of sale.
- 13.) **Event Management** - Responsible for notifying/making available all Park rules/regulations to participants in their event. Included but not limited to Exhibitors', Officials and Volunteers. Exhibitor problems and requests must be relayed to show management to facilitate prompt attention. All Park personnel will respond immediately to emergencies.
- 14.) **ELECTRICAL EQUIPEMENT:** All electrical equipment must be in compliance with the State of Kentucky Fire Code. The Kentucky Horse Park will no longer allow any of the following in stalls, barns or tents: a) two prong plug appliances; b) any 2 prong plug extension cords; c) light duty cords for indoor use; d) any 3 way adaptors unless specifically for out door use; e) any adaptor without 3 prong connections.

**STALLS** - Kentucky Horse Park Stalls: Stalls are 10 by 10 wood plank, asphalt flooring, with full height sliding door. The front of stall and sliding door has round bars upper half. There are doors on all stalls. **There are metal drainage grates in front of some of the stalls.** Stalls may not be painted, marred or damaged in any way. The driving of nails, screws, staples, etc is strictly forbidden.

### MOTORIZED VEHICLE RULE

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of recognized competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will be cause for sanctions against the parent(s), guardian(s), and /or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Rule 8. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
